- ✓ Unauthorized access or hacking of smart appliances through app
 - ✓ Data loss due to appliance malfunction
 - ✓ Reset and secure wipe services
 - ✓ Remote deactivation and troubleshooting

4. WHAT IS NOT COVERED

This policy does **not** cover:

- Cosmetic damage not affecting functionality
 - Theft, loss, or intentional damage
 - Pre-existing conditions
 - Damage due to pests, mold, or weather events
 - Unauthorized repairs or installations
 - Software updates or device obsolescence

All claims must be filed within **10 days** of incident discovery.

 - Report suspicious privacy issues promptly
